# CARF Accreditation: A standard of excellence

ARI of Connecticut sustained their accreditation by the Commission on Accreditation of Rehabilitation Facilities for another three years. This is significant when one considers only 20% of agencies in Connecticut are CARF accredited.



#### What does it mean to be accredited?

When an ARI service or program is CARF-accredited, it means it has passed an indepth review of its services. It is assurance to our consumers and their families that ARI meets rigorous guidelines for service and quality—an

unquestionable endorsement that ARI conforms to nationally and internationally recognized service standards and is focused on delivering the most favorable results to those we serve.

After ARI applies for accreditation of its services or programs, CARF sends professionals in the field to conduct an on-site survey to determine the degree to which the organization meets the standards. This occurred at ARI in June of this year. CARF surveyors also consult with staff members and offer suggestions for improving the quality of services.

"Being CARF accredited is a reflection of the quality of services provided by ARI. It is also a reflection of how seriously we view our mission of enriching the lives of the people and their families that we serve," commented Cecelia Camp, Director of Professional Services. According to CARF, ARI demonstrated that they substantially meet internationally recognized standards. Our consumers and their families can be confident that ARI has made a commitment to continually enhance the quality of its services and programs and its focus on the satisfaction of the persons served. Additionally, when an organization receives CARF accreditation it is assured that:

Libby has been on the go since her mother dropped her off at the ARI Nursery School, then located at the



Jewish Center on Strawberry Hill, when she was three. Recently Libby participated in the 2005 Summer

Olympics in New Haven. She won 2 silver medals (50 and 25 yard free style) and a 5th place ribbon. In fact, her dresser is loaded with dozens of medals. Swimming, golf, bocce, even beating Palermo staff at the game of Trouble . . . Libby loves competition!

"We never kept her from anything. We encouraged her to do whatever she wanted" says Mrs. Ryan. Both mother and daughter are especially proud of the medals Libby won at the International Olympics in Michigan in 1975 when Libby was 14. Libby beat 40,000 other swimmers from around the globe to win the gold in the 25 yard freestyle. She also earned a silver medal in the 100 yard freestyle relay.

The water wasn't always smooth for Libby, however. When Libby was five a piano toppled onto her and dislocated her neck, keeping Libby in traction for months. Additional surgeries and months of rehabilitation didn't deter her spirits. Old photos always show Libby with that little grin. It was at the Newington's Children's Hospital that a caring nurse gave Libby her nickname.

Swimming made Libby stronger. At age 15 she taught youngsters at Camp Jaycee to swim. Even when Libby had open heart surgery at age 22, she was in the pool two weeks later. Carpel tunnel syndrome? After the stitches for surgery were removed Libby was bowling again.

Libby transitioned from home into Palermo House a year ago, along with her childhood friend Mark (Woody) Woodhall. There she continues with many of the activities she did with her family—cooking, baking, watering the plants.
