
Yes, I CAN!

Advocating, learning, reaching and exceeding goals, and enjoying the simple things in life are important steps toward independence and happiness. ARI is proud to share some recent accomplishments made by three of our clients that reflect these values. These stories illustrate our work of providing the right tools needed for success.



"The Self-Advocacy group allows us to learn more about our community and teaches us to speak up and make change," says **Latoya**, a member and leader of the Self-Advocacy Group. Not only an advocate for herself and other clients at ARI, but Latoya is an artist and a member of the Life Skills group at ARI. She

has learned myriad skills that have allowed her to speak up for herself. Latoya works with Darlene Caviness, Manager of Day Service Options in developing meetings for the Self-Advocacy Group. Her leadership has facilitated trips to the State Capital and other places to learn more about the community. She also helped create the "Self-Advocacy Staff Award" that was voted on by clients at ARI and given to a staff member that best helps clients reach their goals and assists in allowing them to become more independent. Latoya continues to work on goals that will allow her to become more independent.



"**Ashley** has grown a lot since beginning at ARI. At first it was difficult to get her involved in activities. She is no longer shy and participates in many classes and events," says a staff member who works with her. Simply put, she has blossomed! Today she participates in computer class, current events class, and is an active

member of her life skills group. She is meeting new friends and attends after-hour parties. Ashley has become a social butterfly.



"I am happy in my own apartment. I am cooking, cleaning and taking the bus on my own. Staff helps me, but not all the time," says **Neftali**. He is the perfect example of how independence can be achieved with the right skills and tools. Over 5 years ago Neftali expressed his desire to work in the community and live in his

own apartment. Neftali is a diligent, hard worker at a local market. He takes the bus to and from work and, with hard work, has seen his hours increase. This past year, Neftali moved out of his 24-hour-staffed group home and into a less restrictive staff-supported apartment with two close friends. He is learning responsibility and self-reliance. As a result, Neftali is living a much more independent and fulfilling life.

"Yes, I CAN" is a phrase we love to hear. Despite decreasing funding from the State, ARI clients CAN and ARE achieving their goals and becoming a greater part of our community. They are advocating for change, giving back to their city, and learning skills that improve their lives. As we venture forth, their futures are optimistic and their own expectations are expanding.

We have included a form for donor opportunities inside. We hope that you will consider making an investment in us by supporting this important fundraising effort. These stories are the results of *your* support. Aside from assuring that we continue to deliver the highest level of service, your investment can help fund, for example, a new handicap-accessible van which will be used to transport clients to classes and events within community. From the CEO



After a difficult winter, ARI welcomes this spring with its promise of growth, adventure and progress.

Despite the change in weather, our challenges will continue, especially with the impact of attendance-based services for day programs. Our payment structure is now based on who attends what program and

when. So, we encourage our clients and families to participate and receive quality services on a regular basis. Clearly, the training we offer helps them achieve their employment (and other) short- and long-term goals. If they are not here, they do not grow and we do not get funded. In addition, we are asked by our state legislators and government partners to provide high-quantity and quality services without cost-of-living increases. This continues to affect our ability to manage our fiscal resources without the increased revenue. While we understand the struggles within the ever-present state deficit, we also have to maintain our commitments to our clients, staff, and business partners in lower Fairfield County. While flat funding is now being seen as a positive rather than negative, it is not an acceptable means of keeping our “guys” moving ahead on their life’s journey towards independence.

The ARI Board of Directors, along with Friends of ARI, is deeply committed to providing mission-driven giving opportunities. In this newsletter, you will notice our upcoming events; The 5th Walk for Independence on May 1, the 16th Lotstein/Martin Golf Tournament on August 18 and the 3rd Annual ARI Comedy Night on October 22. By attending one or all you can help us overcome the reality of our funding gaps.

Another way to help is to contact your legislators in support of the Connecticut Safety Net Program, whereby families receive case management services through a network of existing community resources and service providers, including ARI. Aside from job and life-skills training, vulnerable individuals or families may receive vouchers to pay for its basic needs, such as food, rent, utilities and clothing.

Meanwhile, we continue to make steady strides in the renovation of our Richmond Hill facility. Phase I of the renovation has been completed and we have received many wonderful comments from families, clients, staff, and our state partners. The building looks great and the windows have already had a dramatic effect on energy efficiency. Some of Phase II has been deferred due to the budget but estimates are still being reviewed with the hope of commencing in December, 2011. Part of Phase II includes a proposal with the City of Stamford via a Federal Housing and Urban Development Community Block Grant. This grant, however, has not yet been approved so we may be looking for other resources. Phases III, IV and V have been put on hold until a capital campaign can be established to garner the much needed support to complete the plans. We'll keep you posted.

ARI continues to be the beneficiary of the good work provided by community agencies such as HomeFronts, Inc. and Rebuilding Together Fairfield County. This month Rebuilding Together Fairfield County will paint the main floor of the Richmond Hill Facility as well as clean up the grounds at Palermo House. An application has been sent to HomeFronts, Inc. asking them to paint the exterior of the Fairfield Avenue Administration facility. We truly appreciate this wonderful expression of giving back to our community and its citizens.

Let me take this opportunity to offer heartfelt thanks to the ARI staff. It has been a long winter and I appreciate all that they continue to do to benefit ARI and the clients that we are here to serve. Many thanks to the Board of Directors for their guidance and support. Their governance and commitment is truly spectacular.

Lastly I thank you, the donors and benefactors, who make our jobs easier with your commitment and dedication to our agency. We thank you for all of your continued support and advocacy as we fulfill our most important mission of “always reaching for independence” for all of our clients.




